### For Clarification:

- 1) Request for Information and Questions
  - a) The RFP scope states "Identify, if any, site drainage concerns." for each lot. Are there any known storm water deficiencies at any of the sites that would necessitate underground storm system work?
    The known locations where poor drainage is present have been identified in the RFP document. New design shall account for proper drainage for each parking lot location.
  - b) Does the RFP "repave" definition in the scope of services mean all parking lots will be totally reconstructed? Or will that be determined by the Engineer?
    Determining whether total reconstruction of each parking lot is needed shall be the responsibility of the engineering team, after obtaining the results of the site surveying and soil borings.

#### 2) Alternates

The selected engineering team shall include an alternate design for a new bus loop and scholars' drop-off and pickup locations for Congress elementary. The concept and feasibility of the alternate shall be presented to GRPS for review and approval prior to including in the bid documents.


3) Bid Clarification
